CONDITIONS AND CANCELLATIONS POLICY OF SPONSORSHIP:

The Sponsor makes the following unconditional and irrevocable statement:

The Sponsor acknowledges that without this statement order shall not be placed to the Event Manager.

1. The Sponsor acknowledges that the Sponsor is entitled to cancel the sponsorship in a written form by email with free of charge in 10 days from the payment receipt of sponsorship.
2. The Sponsor acknowledges that in case the cancellation is concluded before than 40% of the already paid sponsorship fee will be paid back by the Event Manager to the Sponsor.
3. In case the Sponsor cancels the participation after the the Sponsor is obligated to pay back 100% of the sponsorship fee to Event Manager and Event Manager is entitled to keep the same amount of advance payment.
4. The Sponsor acknowledges that the legal consequences of delay, default of performance or failure cannot be used in case of a condition that neither of the Parties is culpable of (vis major, epidemiological situation, emergency condition). The Event Manager is not responsible for delay, default of performance or non-performance if the performance is not possible, impracticable or unreasonable to be performed, or for any reason which is not originated from the intentional behavior of the Event Manager, independently of its predictability. Parties are obligated to notify the other Party about the unavoidable obstacle of the performance. The Party in omission is liable for the damages occurring from the failure of notification.
5. The Sponsor acknowledges that Event Manager is not liable for the impossible performance if it is due to an extraordinary condition, action, or event (for example the new corona virus, vis major) which was unforeseeable and which could not be prevented with the expected diligence of the Event Manager in the particular circumstances or could be prevented by unreasonable intervention. In these cases, 10% of the sponsorship fee shall be paid back.

6. The Sponsor acknowledges that Event Manager is entitled to postpone the conference in case of cancellation by the performer or lack of interest. In this case Event Manager informs the Sponsor via e-mail and registers with the consent of the applicant to the next possible date or pays back 10% of the sponsorship fee on specific written request. The Sponsor is not entitled to be covered for any further costs.
7. The Sponsor acknowledges that the Event Manager is not liable for the incorrectly indicated price when the error is not the result of the lack of diligence of the Event Manager or is the result of the error in system, or in case the price is the reason of a manifest error, is unreal and relevantly different from the obvious price of the service. In these cases, the Event Manager is not obligated to provide the participation opportunity for the Sponsor on the price incorrectly indicated on the website. In case of the incorrect price the Event Manager notifies the Sponsor as soon as possible on the incorrectly indicated price and offers to buy the product on the relevant price. In this case, Sponsor is entitled to decide to purchase the product on the relevant price or to withdraw from the contract without penalty.
