## **2) General Terms and Conditions**

### **2.1) Payment Methods**

Make sure you have your name, address and indication "PPXXII" on all method of payments.

Registration fees shall be paid in the following ways:

#### **a./ Online Credit Card payment**

Online bank card payments are executed via the Barion system. The merchant does not get and store any payment data (such as bank card, bank account, or digital wallet details). Barion Payment Inc., the provider of this service, is an institution under the authority of the Central Bank of Hungary, its license number is: H-EN-I-1064/2013.

Barion Payment Zrt. (Address: 1117 Budapest, Irinyi József utca 4-20. 2. emelet) provides the possibilities of secure card acceptances for the online registration system of Plastic Pipes Conference.

The card processing system uses SSL protocol. In case of credit card payment including of using AMEX cards, we redirect you to the payment surface of Barion Payment Zrt., where the payment is directly carried out, because the payment surface is not on the registration sites of Plastic Pipes Conference.

The site of Barion Payment Zrt. works according to the rules and safety standards of the international card companies. Evacon Kft. does not have access to your card number expiry date, or any other data related to your account in any form.

The security of the parties in the bankcard transactions is guaranteed by the Internet Code Security service, i.e. Verified by Visa and MasterCard Secure Code, introduced by the international card companies and also applied by Barion Payment Zrt. With that solution, the cardholder must also enter a password or ID code on the Bank's payment interface (two factor authentication) if the issuing bank made it available, and therefore fraud is practically excluded.

If the credit card transaction is rejected, please contact your bank and confirm payment transaction.

#### **In case of online credit card payment, the following data will be requested:**

- The card number is embossed or printed on the front with 13 to 19 digits.
- Date of expiration:
- The card is embossed or printed on the front with mm/yy format number.
- Validation code (CVC2/CVV2):

The last three digits of sequence in the signature panel, on the back of the card: CVV2 or CVC2.

In case of successful payment, the message about the confirmation will be sent to the customer by email in the next 10 minutes. The invoice also be sent to the customer by email, based on the Hungarian regulations, within 5 working days.

### Payment by bank card

Registering for the PPXXII is comfortable and secure through payment by bank card. After ordering the selected service we direct you to the Barion Payment Zrt. website where you can pay with your bank card through an encrypted transaction that is currently considered the safest. The customer only has to click on the “payment by bank card” button when choosing the payment method, and then they have to type in the card number and the expiration date of their bank card on the Barion Payment Zrt. payment server. Barion Payment Zrt. accepts VISA, VISA Electron, V-Pay, MasterCard, Maestro, AMEX and JCB type bank cards. Bank cards authorized only for electronic transactions are only accepted if the usage of the card is authorized for this purpose by the issuing bank for that card. Please inquire at your bank whether your card can be used for internet shopping. Barion Payment Zrt. will issue an authorization number for the transaction. The customer should write the number down, or print out the whole page. In case of an unsuccessful transaction, Barion Payment Zrt. will send an error message and the cause of the error.

### Security of personal data, data protection

Protection of your personal data is a priority for Evacon Kft. and its partners. Collecting and processing of personal data necessary for identification during the usage of our website complies with the data protection standards in force in Hungary (Law CXII. 2011). Your data will be handled confidentially; your data will not be given out to any third parties, unless it is necessary for the fulfillment of the contract (e.g.: billing, shipping, courier service).
